## 2020: A Year We Created a Brighter Future Despite Challenges

Management guru Peter Drucker has a simple dictum that "You cannot predict the future, but you can create it". I often think of this when reflecting on the year that has been.

It is hard to overstate the enormous harm caused by the COVID-19 pandemic and its associated lockdown measures across many walks of life, and not least cancer care. I, my Board colleagues and all the E.C.O. family are determined to do all we can to continue raising the alarm about the late diagnosis wave coming. We need to ensure every citizen understands, that when it comes to cancer or any other lifethreatening disease, never, ever, put it off. However, it is also critical that we do not permit such ill wills to blow us off our longer-term course.

At the European Cancer Organisation, during 2020, we were determined that we would not allow external events to slow down the momentum of implementing our four-year <u>Strategy</u>, establishing nine new powerful <u>Focused Topic Networks</u> of collaboration and consensus building, as well as launching a new brand in addition to a new website. I have been delighted that the European Commission and European Parliament, under the leadership of Ursula von der Leyen, have undertaken the exact same spirit by investing €5.1 billion in the EU4Health 2021-2027 programme, establishing the EU Cancer Mission, producing Europe's constructive new Beating Cancer Plan, and conducting ground-breaking scrutiny work on cancer policy. After many years of our <u>Member Societies</u> and <u>Patient Advisory Committee</u> advocating for real action on cancer, finally important new initiatives are under way.

All of this means that, as I look ahead to 2021 and beyond, despite the great work ahead of us in rebuilding cancer services post or along COVID-19, it is with good grounds for optimism that better is on its way, as we now turn to the important business of implementation.

### MESSAGE FROM THE PRESIDENT

#### **Europe's Beating Cancer Plan offers us:**

- A pan national goal for HPV cancer elimination
- New binding targets on tobacco use reduction, screening access and comprehensive cancer care provision
- Commitments to the public measurement of cancer inequalities to allow more targeted intervention for their reduction
- Laudable ambitions on prevention policy, from alcohol and food labelling, to air quality improvement and tobacco taxation
- New change-making initiatives on topics such as interdisciplinary education, cancer imaging, genomics, diagnostics, drug repurposing and cancer survivor needs

Allied to this, and all of the fabulous work conducted by our professional members and patient organisations, the European Cancer Organisation too has been making new and important contributions through its advocacy activities and the nine Focused Topic Networks, set up in less than a year, including:

• The launch of the European Code of Cancer Practice – a long lasting tool, already translated in 25 languages, to better embed cancer cancer patient rights and cancer patient empowerment in every healthcare system

- New policy publications such as:
  - Strengthening Europe in the Fight Against Cancer
  - The Impact of COVID-19 on Cancer in Europe: The 7-Point Plan to Address the Urgency and Build Back Better
  - <u>Viral Protection: Achieving the Possible. A Four Step Plan</u> for Eliminating HPV Cancers in Europe
  - It Can Be Done Beating Inequalities in Cancer Care
  - Free from Cancer: Achieving Quality of Life for All Cancer Patients and Survivors
- The publication of three new tumour types in our <u>Essential</u> <u>Requirements for Quality Cancer Care</u> series – <u>Breast</u>, <u>Prostate</u> and <u>Lung</u>.
- The creation of the European <u>Quality Cancer Care</u>
  <u>Catalogue</u> to provide a one-stop-shop for anyone looking for the off-the-shelf tools and techniques already available to help improve cancer care across its many facets

In this Annual Report you can find further details on the policy work of the organisation and the key outputs (and advocacy successes) of our Focused Topic Networks, convening our Member Societies, Patient Advocacy groups and invited stakeholders.

The European Cancer Organisation works with all party groups and all Committees to ensure strong parliamentary attention to arising opportunities for improvement in EU cancer policy and issues requiring greater political attention.

2020 has seen the infrastructure of European Parliament advocacy on cancer policy grow with the establishment of the Special Committee on Beating Cancer (BECA), and the Cancer Challenge Intergroup, working alongside the MEPs Against Cancer Group.

The European Parliament will likely be the guardian of the Beating Cancer Plan's implementation, keeping helpful pressure for success. We are pleased to count on so many MEPs as friends of our shared mission: improving outcomes for cancer patients in all parts of Europe.

## **The Wider World**

The European Cancer Organisation believes in the fundamental principle that we achieve more in all walks of life when we work together.

At the international level, we believe Europe has a leadership role to fulfil in all areas of cancer policy, from prevention to diagnosis, treatment to survivorship, and in research.

With cancer a common societal challenge in every nation, there are enormous learnings to be untapped from formal and informal exchange, enabling organic partnerships to emerge and collaborations to grow.

For that reason, we welcome and invite international organisations from across the globe to participate in our policy activities via our Focused Topic Networks, and actively involve our leaders in global level projects that aim to help all countries go further, faster in the fight against cancer.

We thank organisations such as the WHO, UICC, WHO Europe, IARC, ASCO, OECD and many others such fruitful open partnership working with us and our Networks.




## Strengthening Europe in the Fight Against Cancer

- The European Cancer Organisation was commissioned by the European Parliament Research Service to convey a <u>report for MEPs</u> on the current state-of-play and opportunities for improvement in cancer policy at the EU level
- The resulting landmark study benefitted from the inputs and oversight of over 60 leading experts across professional fields and patient constituencies
- Chapters analysed the current landscape in areas such as:
  - Causation and prevention of cancer
  - Policy needs for achieving earlier detection and diagnosis of cancer, including screening strategies
  - Means for improving cancer treatment and care in Europe, as well as research
  - The specific requirements and opportunities for progress for rare and childhood cancers
- The 45 recommendations contained in the report have provided a key reference point for decision-makers in the Parliament and Commission and an ongoing basis for our representations



## **Focused Topic Networks**



### **CONVENING THE CANCER COMMUNITY**

### On behalf of its <u>Member Societies</u> and <u>Patient Advocacy Groups</u>, the European Cancer Organisation convenes interested stakeholders around <u>nine important topics</u>.

Led by co-chairs from our Member Societies, these Networks have been established to facilitate consensus and joint projects in our <u>Strategy 2020-2023</u>. The programme of the <u>European Cancer Summit</u> is also based on these nine topics.

Focused Topic Networks do not have a decision-making role in policy work. Where policy needs are identified during Network discussions, our Member Societies are able to make proposals through our <u>policy</u>. <u>approval pathway</u>. When policies have been agreed, our Focused Topic Networks support the campaign for the implementation of these policies.

Prevention is key to cancer control but policy recommendations in this area are not always without controversy. **The <u>Prevention Network</u> aims at** fostering fresh consensus and stronger collaboration in all areas of cancer prevention among key interested expert groups and policy-makers, at European and international level, in order to both decrease cancer incidence and advance cancer detection.

Summit 2020, entitled "Early Detection Saves Lives: Taking European Cooperation on Cancer Screening to the Next Level". The session featured a lively high-level discussion between all key stakeholders involved in cancer screening, including oncologists, patients, policy-makers, experts and industry representatives.

A major activity for the Prevention Network in 2020

has been the session held at the European Cancer

A consensus <u>resolution</u> was passed, calling for taking European cooperation on cancer screening to the next level and highlighting key recommendations of the Network to achieve progress. **Europe's Beating Cancer Plan** includes two pillars on cancer prevention and early detection, with strong measures including:

- A new EU Cancer Screening Scheme, ensuring 90% target population coverage by 2025 and considering the recommendation of additional cancers, such as prostate, lung and gastric cancer
- An update to the European Code Against Cancer and specific action against all main cancer risk factors (tobacco, alcohol, nutrition, infections, UV)

The EU Cancer Mission and the agreed EU4Health Programme also contain dedicated provisions to fund research and actions aiming at strengthening access to prevention and early detection of cancer.

- Continue developing a holistic approach to cancer prevention
- Play a major role in the strengthening and implementation of Europe's Beating Cancer Plan and other relevant policy initiatives

The <u>HPV Action Network</u> was launched in December 2019, following the resolution passed at the 2019 European Cancer Summit: "**By 2030, effective strategies to eliminate cancers caused by HPV as a public health problem should be implemented in all European countries**".

The HPV Action Network urges Europe to make HPV cancer elimination a formal European shared goal.

Achieving the possible, formed the basis for the **Network's advocacy work** on the Beating Cancer Plan, calling for the implementation of genderneutral HPV vaccination programmes, better cervical cancer screening programmes, adoption of best-practice treatments for all HPV related cancers as well as improved education and awareness for both patients and health professionals.

Published in October 2020, the report Viral Protection:

After the successful <u>session at the European Cancer</u>. <u>Summit 2020</u> called "Viral Protection: Achieving the Possible. The elimination of HPV cancers in Europe" which saw two important <u>resolutions</u> passing, our Network Co-Chair Daniel Kelly presented the case for gender-neutral HPV vaccination throughout the EU to the Special Committee on Beating Cancer (BECA) at a public hearing at the European Parliament on 2 December 2020 with great consensus achieved. **Europe's Beating Cancer Plan**, published on 3 February 2021, turned into concrete results many of the HPV Action Network advocacy efforts:

- With dedicated funds under the EU4Health programme and elsewhere, member states will be supported to extend routine HPV vaccination against HPV to girls and boys
- There will be action on cervical cancer screening through a new EU-supported Cancer Screening Scheme to help member states ensure that 90% of women are offered screening by 2025
- The Knowledge Centre on Cancer will provide new guidelines and quality assurance schemes on cervical cancer screening, diagnosis, treatment rehabilitation, follow-up and palliative care

With the advent of innovation at an unprecedented pace in the cancer field, health systems are being faced with increasing challenges to ensure development of optimised treatments and their equal access by all cancer patients who need them. **The <u>Health Systems and Treatment Optimisation Network</u> aims at providing solutions to elevate the ability of European cancer control strategies to foster, identify and measure cancer treatment innovation, translate it into treatments and deliver them to cancer patients.** 

A major activity for the Health Systems and Treatment Optimisation Network in 2020 has been the session it held at the European Cancer Summit. 2020. The session featured an open exchange between leading experts and wide-ranging stakeholders on key challenges to be addressed in order to achieve the Network's aims, including current gaps to the cancer research continuum in Europe.

A consensus <u>resolution</u> was passed, calling for support to independent multidisciplinary cancer research, addressing questions relevant and meaningful for patients and public health. **Europe's Beating Cancer Plan's** 'Cancer Diagnosis and Treatment for All' initiative recognises the goals of optimising treatment and increased access to therapeutic innovation.

The proposed EU Cancer Mission also includes several references to the need for treatment optimisation, while the new EU Pharmaceutical Strategy mentions providing support to academic pragmatic trials, improving treatments by identifying optimal doses and combination with other treatment modalities.

These developments represent initial recognitions of the issues raised by the Network and echo the intense advocacy efforts it conducted in 2020 to build strong support around its mission and vision.



#### Looking forward to 2021:

- Further develop its strategy to bring the optimisation of health systems and treatments in cancer to the top of the European health agenda
- Publish an advocacy document outlining key immediate asks of the Network to achieve its aims

The European Quality Cancer Care Catalogue, launched at the European Cancer Summit 2020, provides a central repository to guide individuals to the tools they will find helpful in improving the quality of cancer care.

Three Essential Requirements for Quality Cancer Care papers were published in 2020:

- Elaborating the Essential Requirements for Quality Cancer Care: Prostate Cancer Launch event held in June 2020
- Advancing Essential Requirements for Quality Cancer Care: Breast Cancer Launch event held in June 2020
- Essential Requirements for Quality Cancer Care: Lung Cancer Launch event held in December 2020



A dedicated section on quality of cancer care was included in Europe's Beating Cancer Plan. This incorporates an EU Network of national Comprehensive Cancer Centres, the goal of a 90% access of eligible patients, as well as the setup of a network of Comprehensive Cancer Infrastructures within and across all Member States.

### Action Report launched in November 2020





A dedicated pillar on quality of life of cancer patients, survivors and carers was included in **Europe's Beating Cancer Plan**, with specific provisions on Return to Work, Right to Be Forgotten and access to follow-up care. It echoes the Network's calls for a holistic approach of cancer survivorship and quality of life, addressing all the needs of cancer patients and survivors.

#### Looking forward to 2021:

The Digital Health session at the European Cancer Summit was a dynamic multistakeholder conversation about the challenges and opportunities for Cancer Care associated with both current technological trends and EU initiatives.

A strong appetite for joint working between stakeholders on topics such as the European Health Data Space and the European Cancer Patient Digital Centre emerged.

As a result, the Network will convene consensus positioning by the Cancer Community on these topics during 2021.

The proposed EU Cancer Mission includes the European Cancer Patient Digital Centre. The European Cancer Imaging Initiative (access to cancer imaging data) as well as the inter-specialty training programme have been included in Europe's **Beating Cancer Plan**.



Cancer control is simply not possible without the cancer workforce. The Workforce Network brings together professionals, patients and others to speak as one about these unaddressed policy needs at the European level and ensure that the right of every cancer patient to specialised multidisciplinary cancer care is upheld and made a reality.

Working together, our Network aims to help:

- Address workforce shortages in cancer care
- Improve opportunities for professional qualification recognition and mobility in the cancer field
- Ensure cancer professionals' safety and well-being
- Elevate cancer education, training and development opportunities

#### The European Cancer Summit 2020 included a session on "Preparing a Resilient Oncology Workforce for the Present and Future". The session



A consensus resolution was passed, highlighting the importance of supporting harmonisation and recognition of cancer professional qualifications through adequate tools at the European level.

Europe's Beating Cancer Plan states that: "Highquality cancer care depends on a high-quality workforce". Supporting this recognition, it includes:

- The creation of a new Inter-specialty cancer training programme, aimed at addressing current skill gaps across the cancer pathway
- A target of access of 90% eligible patients by 2030 to recognised national Comprehensive Cancer Centres

Additional provisions, such as the new Cancer Inequalities Registry and the promised update of the Carcinogens and Mutagens Directive, are also seen as promising opportunities to further advance the Network's key asks.

#### Looking forward to 2021:

- Developing and publishing an advocacy document providing policy recommendations on the four priorities of the Network
- Bringing the attention of the European Parliament's Special Committee on Beating Cancer (BECA) to workforce issues
- Promoting the <u>Accreditation Council of</u> <u>Oncology in Europe (ACOE)</u> that provides accreditation to Continuing Medical Education (CME) providers

### **Revised Statutes**

To comply with the new Code for Belgian non-profit associations, introduced at the start of 2020, the European Cancer Organisation set up a Governance Review to include the revision of our Statutes with a full consultation of our Member Societies.

The revised Statutes now include the concept of affiliations and collaboration agreements in addition to the existing E.C.O. membership which remains unchanged. The concept of Board "delegates" was also removed, in compliance with the new Code.

The new Statutes were agreed in principle at the General Assembly on 17 November 2020 and formalised with the Belgian notary on 29 January 2021.

We thank Prof Hein Van Poppel (EAU) and Dr Lore Decoster (SIOG) for their availability to join the meeting in person and sign the deed on behalf of the voting Member Societies.



## **Our Broad Coalition of Support**

At the start of 2020, we launched <u>Community 365</u>. This is a broad group of charity, philanthropy and industry contributors to the Focused Topic Networks of the European Cancer Organisation. It replaces the previous model of healthcare industry sponsorship of events.

Community 365 provide ideas, guidance, practical support and resources for our work in convening stakeholders and building consensus in the European cancer community. Community 365 contributors do not have a decision-making role in our policy work.

Policies of the European Cancer Organisation are agreed by our Board after consultation with our Member Societies and Patient Advisory Committee.

Community 365 also has additional not-for-profit organisations as Supporters of our Mission & Vision, Strategy and Focused Topic Networks.



## **Policy Decision Making Process**


When agreeing policy within the European Cancer Organisation, our paramount principles are:
