ECO PROVIDES EVIDENCE TO UK HOUSE OF COMMONS INQUIRY

At the beginning of this year, ECO was invited to give oral evidence at a hearing of the UK Parliament's <u>House of Commons Health Select Committee</u> which took place on Tuesday 9 January 2024 on the innovations with the greatest potential to transform cancer diagnosis and treatment for patients evidence to the and its inquiry into <u>'Future Cancer'</u>.

<u>Professor Mark Lawler</u>, ECO Board Member 2020-23 made key points to the Committee, including:

- 1. Recognising the abundant opportunity for all countries to do better on early detection, and diagnosis of cancer;
- 2. **Promoting the usefulness of goal-orientated cancer policy, including s**etting clear goals in any field of activity provides clarity, planning certainty and political accountability. It also unites diverse stakeholders by establishing common goals to which all must play a part. It can also serve as a vital mechanism for addressing inequalities in cancer care via its universal approaches.
- 3. **Opportunities for international collaboration.** In this spirit, ECO's recently published '<u>Time to Accelerate: Together Against Cancer</u>' publication, supported by more than 70 organisations from across Europe and around the world, has articulated a shared enthusiasm in the European cancer community for the UK to be welcomed into EU level cancer cooperations. Under Europe's Beating Cancer Plan and the EU Research Mission on Cancer.

Accelerating the EU's Commitment to Beating Cancer

On Wednesday 31 January at the European Commission headquarters in Brussels, *the Commissioner for Health and Food Safety, Stella Kyriakides,* celebrated three years after the publication of the most advanced and promising political agenda on cancer: the Europe's Beating Cancer Plan. In particular, the European Commission presented a key recommendation to eliminate cervical cancer in Europe and prevent a number of cancers connected to viruses such as HPV and HBV.

In particular, ECO welcomes the recent publication by the European Commission proposing Council Recommendations on vaccine preventable cancers, which include:

- the call for the development of a national coverage tracking dashboard by the European Centre for Disease Prevention and Control, the recommendation for free and school-based delivery of both vaccinations, increased awareness campaigns on cancer risks; 5
- the suggestion to make hepatitis B (HBV) vaccination routine in drug treatment programs and prisons. Additionally, the proposal advises countries to simplify procedures for obtaining parental consent to vaccinate minors.

We also urge a renewed commitment to HPV cancer elimination, aligning with the Europe's Beating Cancer Plan and WHO Cervical Cancer elimination strategy. This

involves endorsing gender-neutral vaccination policies and surpassing vaccination coverage targets.

It represents the result of inputs and consultations with many organisations and individuals active in pan-European cancer policy cooperation, and specific consultation with the <u>Focused Topic Networks of the European Cancer Organisation</u>.

The recommendations reflect experiences and perspectives gathered during an unprecedented five-year period in EU cancer policy, with landmark attention and
